Post and District audits are very important and the National By-Laws state they must be filed with the Department every quarter. Audits are now due for the December 31, 2017 quarter. There are still audits due for September 30, 2017. Please get your audits in as soon as possible. If you need help please contact me.

Beginning on Jan. 1, 2018, the standard mileage rates for the use of a car (also vans, pickups or panel trucks) will be:

- 54.5 cents for every mile of business travel driven, up 1 cent from the rate for 2017.
- 18 cents per mile driven for medical or moving purposes, up 1 cent from the rate for 2017.
- 14 cents per mile driven in service of charitable organizations.

The business mileage rate and the medical and moving expense rates each increased 1 cent per mile from the rates for 2017. The charitable rate is set by statute and remains unchanged. Many of us use these rates for our Travel reports and other reports.

The Department 50% Life Membership Program is going well. I would just like to repeat that we discourage the use of a credit card to pay the Veterans half. The Department cannot process credit cards. Credit Cards cannot be used online with national for the 50% program, which means they have to be sent to National for processing.

This can sometimes take over a month. As of the end of December 2017 we have 159 New or Converted Life Members for this program year. The total cost as of December 31, 2017 was \$ 23,246.50. The Council of Administration approved the program for a 3 years period at a maximum expense of \$50,000.00. The funding has been extended once for another \$50.000.00 by the Council of Administration.

As most of you already know, I will be a candidate for State Quartermaster at the State Convention again this year. I would like to ask you all for your support. Thank you.

Lastly, I would like to thank you all for the Cards and Prayers during my surgery & Chemo it has been a rough few months, but I am feeling much better now and ready to go.

As of February 8th, 2018, 68 bills had been introduced in the General Assembly that were considered to be of interest to veterans. The most significant bills were those that would expand the exemption of military retirement pensions from State income tax. As I had mentioned in a previous column,

Governor Hogan supports such legislation.

During last year's session, the Senate also supported the exemption, but the companion bill was not approved by the House Ways and Means Committee.

A reminder that all proposed amendments to either the Department or National By-Laws to be considered by the Department Convention in June, must be submitted in writing to the Department Adjutant no later than the close of business on Monday, April 16th, 2018. If your Post is planning to submit an amendment and needs assistance, please feel free to contact me and I will be glad to help.

Comrades, Brothers and Sisters,

While our winter has been fairly mild, I know the cold and flu season has taken its toll on many of our families. Keep all of our Comrades, Brothers and Sisters in your thoughts and prayers.

March and April are key times for the Auxiliary as Election of Officers and Delegates will take place. Please refer to your Auxiliary By-laws, Article VIII Officers, Sec. 801 – Eligibility (anyone in good standing is eligible to hold an office); Sec. 802 – Elective Officers (identifies what Officers are to be elected); Section 803 – Appointive Officers (identifies what Officers may be appointed). Section 804 – Election - 804A – Auxiliary specifically the second bullet "Elective Officers shall be nominated and elected at the regular business meeting in APRIL."

Nominating committees are permitted and many Auxiliaries hold their first nominations at their March meeting, and close and elect at their April meeting. By doing so they know which positions are "filled" and which positions will need to be "filled" before the night of the actual election in April. Also, a member who wishes to be nominated and elected to a position either needs to be present at the election or provide in writing their willingness to be elected and hold office. And do not forget to elect your Delegates to your District, Department Convention and National Convention (even if there isn't anyone attending the National Convention, it is good practice to elect your allowable delegates and enter them into the National database).

Installation of officers can either be done at the April meeting immediately after election or at a separate or joint function with their VFW Post in late April or <u>early</u> May. Please do not wait to elect and install at your May meeting!

Presidents and Secretaries, watch for more information in a separate mailer in March which will contain your paperwork for reporting your election of Officers and Delegates. MALTA's Installation reporting area now has all offices available for data input, so when you complete the Election Report worksheet, be sure to have all accurate information for data entry. Please clarify Member ID numbers for accuracy, as well as addresses, phone numbers and e-mail address. If your officer held a position last year, do not assume that there has not been a change in information, ask! Please complete the information requested on the entire form and either have your Secretary input the data or send to me within five (5) days of your installation so that I can update the National database. Since members are required to show their membership cards at all meetings, you should have that information available at the time you complete your report.
