



Comrades.

We are once again starting a new year, and with that comes time to make sure you have the items in place to make sure you are operating in compliance with the VFW, the State of Maryland and Washington D.C.

Some of the items that you may need to review are:

- Quartermaster bonded, (Posts with outside bonds must submit a copy to the Department)
- Bank account signatures updated
- Current 990
- Quartermaster access to OMS (Online Membership System)
- Bank statements, back-up documents for expenditures
- Liquor licenses are up to date (Post's with Canteens)

Trustees remember that your signature on the Trustee audit report certifies that:

- You audited the books and records of the Adjutant and the Quartermaster
- You certify that they are true and correct.

The 50/50 life membership program is still in effect. Remember that the person must be a member of a post for at least one year to be eligible.

Program Goal:

- To increase Post Life Membership and convert existing Annual Members to Life Members.
- Free up efforts to recruit new members versus spending time chasing down existing members to pay annual dues.
- Increase Life member rebates to the Posts and Department.

Program Parameters:

50K pulled from the investment account to fund the program for a 3-year period (or until funds are exhausted and not voted by the COUNCIL OF ADMINISTRATION to be replaced).

For any existing annual member of a Maryland Post the Department of Maryland will pay 50% Percent of the member's Life Member Dues. This Program is not available for "New" or "reinstatements"; "New" or reinstatements" must join/rejoin a Maryland Post first and be in good standing for a period of 1 year. This program is also not for "At Large" Members, unless they join a Maryland Post first and are members in good standing for 1 year.

This membership program is a great benefit and a valuable tool for recruiting new members as it provides a substantial savings over a period of years to younger members. Indicated below are the potential savings based on age brackets:

Requirements to process:

All applications for this program will be processed thru the State Quartermaster after receipt from the Post Quartermaster.

ALL applicants will need to submit an application, DD Form 214 or other acceptable proof of service and payment of their half of the proper life dues according to their age.

September is National Suicide Prevention Month



Don't become obsessed with numbers. We hear 22 a day over and over again, one Veteran committing suicide is one too many. The Veteran suicide rate is higher than those who never served in the military. The actual number of Veteran suicides is closer to one a day, as I said, one is too many. The numbers are higher among Vet-

erans that never went to Iraq or Afghanistan, which suggest the causes extend beyond war trauma.

If you didn't attend the National Convention in Florida some interesting statics were passed along. In suicides where a firearm was used 85% are successful, less the 5% when a fire arm wasn't used.

As a group, Veterans are firearm owners. We all solemnly swore an oath that never expires to support and defend the Constitution of the United States against all enemies. Makes sense we as a group have firearms and will not turn them over, unless it's to a brother or sister Veteran to hold while the individual works on the issues that are making them suicidal. I have done this for several Veterans personally, it works. Ask them if they don't ask you to hold their guns while they work through this, be ready to leave your home in the middle of the night just so they can talk and you listen. In two cases they asked me to come get their firearms, in three I asked them. All five have their firearms back and we have lifelong friendships.

VA RELEASES LAUNCHPAD APP TO STREAMLINE HEALTH CARE ACCESS FOR VETERANS AND CAREGIVERS

The U.S. Department of Veterans Affairs (VA) recently launched a new mobile application designed to save Veterans and their caregivers time online. VA Launchpad for Veterans simplifies and organizes several existing tools and resources into one convenient location to help manage healthcare needs. "VA has developed dozens of apps for Veterans to take charge of their health care," said VA Secretary Robert Wilkie. "VA Launchpad makes it easier to have these important tools available at your fingertips. "VA Launchpad arranges all of VA's apps into five categories for Veterans: health management, health care team communication, vital health information sharing, mental health improvement and quality of life improvement. The new app enables Veterans to access all the features with a single secure login. The app also includes many mental health care and personal improvement tools for individuals who are not enrolled in VA health care services. These tools are free and do not require secure logins to use. VA Launchpad for Veterans is available for download in the Apple App Store and Google Play. To access VA's secure apps within VA Launchpad, users must be a VA patient and have one of the following accounts: Premium My HealtheVet, DS Logon Level 2 (Premium) or ID.me.

With <u>VA Launchpad</u>, you can access apps that allow you to:

- Manage your VA health care
- View and share your VA Electronic Health Record (EHR)
- Share health information that you entered yourself with your VA health care providers
- Book your own VA appointments
- Refill a VA prescription
- Communicate with your VA health care providers
- Improve your health using apps designed for special health related issues



VA UPDATES THE DISABILITY RATING SCHEDULE FOR INFECTIOUS DISEASES, IMMUNE DISORDERS AND NUTRITIONAL DEFICIENCIES

As of Aug. 11, the U.S. Department of Veterans Affairs (VA) updated portions of the VA Schedule for Rating Disabilities (VASRD, or Rating Schedule) that evaluate infectious diseases. immune disorders and nutritional deficiencies.

The collection of federal regulations used by the Veterans Benefits Administration helps claims processors evaluate the severity of disabilities and assign disability ratings.

"VA is in the process of updating all 15 body systems of the VASRD to more accurately reflect modern medicine and provide Veterans with clearer rating decisions," said VA Secretary Robert Wilkie. "By updating the rating schedule, Veterans receive decisions based on the most current medical knowledge of their condition."

The complete list of updates to the rating schedule is available online. Claims pending prior to Aug. 11, will be considered under both the old and new rating criteria, and whichever criteria is more favorable to a Veteran will be applied. Claims filed on or after Aug. 11, will be rated under the new rating schedule.

Updating the rating schedule for conditions related to infectious diseases, immune disorders and nutritional deficiencies, enables VA claims processors to make more consistent decisions with greater ease and ensure Veterans understand these decisions. VA remains committed to improving its service to Veterans continuously and staying at the forefront of modern medicine as it has for decades.

Since Sept. 2017, VA has updated the schedules for dental and oral conditions, conditions related to the endocrine system, gynecological conditions and disorders of the breast, the general rating formula for diseases of the eye, skin conditions and the hematologic and lymphatic systems.
